- Charlotte - I-85 N to I-40 E to Exit 289, Wade Ave., to Blue Ridge Rd exit, turn right on Blue Ridge, hotel on left.
- Richmond - I-95 S to Rocky Mount, NC, then US 64 W to 440 N to Exit 4B. Keep right to Blue Ridge Rd., then turn left on Blue Ridge Rd., hotel on left.
- Wilmington - I-40 W to exit 289, Wade Ave. to Blue Ridge Rd. exit. Turn right onto Blue Ridge, hotel on left.
